PAYMENT INFORMATION:

Annual registration fee and monthly fees will apply

Registration fees for 2026 is **R1150** once off per player for the 2026 season. This will include 1 full kit (top shorts and socks) and an extra T-shirt for away games, 2 x training t-shirts as well as academy and league registration costs for players. Players are to wear training t-shirts for training only and no other team kits will be allowed. **PLEASE NOTE THIS IS CASH ONLY.**

Please note referee's fees, tournament fees and transport costs are the responsibility of the player and is excluded from this cost. All tournament fees are excluded from this as well. All registration fees to be paid by the <u>31st January 2026</u>. Kits ordered once proof of payment is issued.

Monthly fees: R600 per player per month for twice a week sessions (February to November)

Early Bird / Black Friday Special – 25% off annual fees – Total R4500 per player but excludes registration fees. This MUST be paid before the 15th December 2025.

Should payment not be paid Hola Skoko reserves the right to exclude the player from training sessions and matches. Any player that wishes to leave the academy for whatever reason must give 1 calendar months written notice in which fees including that month must be up to date. Fees are payable regardless of whether the player has been in training as the academy runs throughout the year ie. Exam time, holidays etc and fees are to be paid in advance for the month ahead.

Banking details are to be requested and each player will receive a unique reference number to be used for making registration and monthly payments.

Please note the following:

- Players with unpaid fees will not be issued clearances at the end of the season.
- Players with outstanding fees will not be permitted to register or join the academy for the upcoming season.
- Participation in forthcoming tournaments will not be allowed until accounts are settled in full
- Year-end certificates will not be issued to players with outstanding balances.

UNIQUE REFERENCE NUMBER FOR PAYMENT

Please contact us to confirm your unique reference number for payment. This reference will be used for player payments from February to November. The unique reference number must be used for payment so we can allocate accordingly eg. LEN236 – Feb 2026 or HOU45 – Feb 2026 (*please do not use this reference we will send you a unique reference number once registered*)

The unique reference plus month must be used. Please note this is for monthly fees only.

REGISTRATION FEES OF R1150 IS TO BE PAID IN CASH ONLY.

Please note kits will only be issued once full payment is made. Players will only be registered for SLFA or JSL league once full payment of registration is made. Registration fees are due by the 31st January 2026.

INDEMNITY FORM FOR PARTIPICATION IN FOOTBALL ACTIVITIES

Acknowledgment of Risk: I, the undersigned, acknowledge that participation in football training, matches, and tournaments involves inherent risks, including but not limited to physical injury, accidents, and other unforeseen events. I understand that these activities are supervised by the football academy, but there is still a possibility of injury or harm.

I, the undersigned parent/guardian, acknowledge that participation in soccer training, matches, tournaments, and related activities with Hola Skoko Academy involves inherent physical risks. These risks may include, but are not limited to, slips, falls, collisions, muscle injuries, fractures, or in extremely rare circumstances, serious injury or death.

I understand that while Hola Skoko Academy takes all reasonable precautions to ensure the safety and wellbeing of players, it is not possible to remove all risks associated with active sport.

Consent to Participate: I hereby give my consent to my child to participate in all football-related activities organized, including training sessions, matches, and travel to tournaments.

Medical Authorization: In the event of an emergency, I authorize the football academy and its representatives to seek medical treatment for my child. I understand that every effort will be made to contact me before any medical treatment is administered.

Indemnity and Waiver: I agree to indemnify and hold harmless, its coaches, officials, volunteers, and representatives from any and all claims, liabilities, damages, or expenses arising from my child's participation in football activities. This includes, but is not limited to, any injury, loss, or damage sustained by my child during training, matches, or travel to and from tournaments.

Supervision and Conduct: I understand that my child will be under the supervision of the football academy during all activities. I agree to ensure that my child follows all rules and guidelines set forth by the academy and behaves in a manner that ensures their safety and the safety of others.

Agreement: By signing this form, I acknowledge that I have read and understood the terms and conditions outlined above. I agree to these terms and consent to my child's participation in football activities.

CONSENT AND AGREEMENT:

I, the undersigned, consent to my child participating in the activities of the Football Academy. I acknowledge that participation in football involves a degree of risk and I agree to hold the Football Academy, its officials, and coaches harmless from all liability for any injury that may occur to my child as a result of their participation.
